headquarters every night for any emergency.

RESOLVED FURTHER, that service truck (Fargo) be made available at the Police Headquarters every night for any emergency, and to return it in the morning;

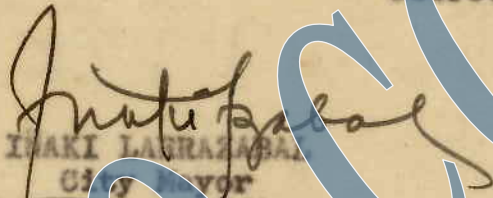
