RESOLUTION NO. 75

WHEREAS, Engineer Felix C. Codilla, City Engineer of Ormoc City who was requested to be present during the deliberation of the Honorable Body, informed the Honorable members of the Board, that when he assumed office as City Engineer of Ormoc City on July 20, 1953, his office had an overdraft in the amount of P40,000.00 as of July 18, 1953;

WHEREAS, Hon. Maximo Malinao, Vice Mayor of Ormoc City manifested, that according to reliable information which he had gathered from the personnel of the Engineering Department, one of the causes of the overdraft was due to the alleged irregularities and anomalies committed by the personnel of said department and Engineer Fernando C. Rondon during his incumbency as City Engineer of Ormoc City;

WHEREAS, on manifestation of Councilor Teotimo Ocubillo, to request the new City Engineer, Engr. Felix C. Codilla, to reorganize his department in order to cover up the standing overdraft abovementioned and to avoid further unnecessary deficit;

NOW THEREFORE, the Board, on motion of Councilor Teotimo Ocubillo seconded by Councilor Alvaro I. Gutierrez;

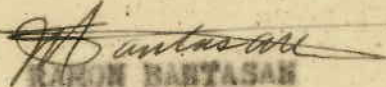
BE IT RESOLVED, as it is hereby resolved, to respectfully request the new City Engineer of Ormoc City, Engr. Felix C. Codilla to reorganize his department in order to cover up the standing overdraft in the amount of P40,000.00 and to avoid further unnecessary deficit;

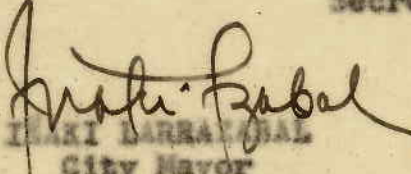
