RESOLUTION NO. 77

Letter of Captain Marcelino Conopio, Chief of
Police, Ormoc City dated August 4, 1953 hereunder quoted
verbatim as follows:

Sir:

I have the honor to inform the Honorable Municipal
Board thru His Honor the City Mayor, that the members of
this department are in urgent need of uniforms. In order
to keep up with at least an average standard of a police
organization particularly the wearing of uniforms for a
more impressive and dignified appearance, most of our
men have purchased their own uniforms on credit. Con-
sidering their present meager pay, it is rather a financial
burden and sacrifice on their part. However, this became
necessary on account of the fact that our requisition
for uniforms could not be acted upon in the absence of
a budget for this fiscal year.

In view of the above, it is respectfully requested
that if the city fund is inadequate at present to meet
the different items of expenditures itemized in the
budget we have submitted to that office for the police
force, the amount recommended for uniforms be considered
among other things, and if possible, action on this matter
be expedited.

I hope that for the good of the service and the
administration, this request be given due consideration
and prompt action.


