RESOLUTION NO. 73-A

WHEREAS, it has come to the official knowledge of the
Municipal Board of this City thru the information given by
Councilor Teotimo Ocubillo, Chairman of the Committee on
Schools, that the City Intermediate School Teachers of the
City of Ormoc have not yet receive their salary correspon-
ding for the month of July, 1953, school year, 1953-1954;

WHEREAS, be it known that the Primary Teachers whose
salaries are chargeable against the national fund have
already received their salary for the month of July, 1953;

WHEREAS, Councilor Teotimo Ocubillo strongly sugges-
ted to the Hon. Body to authorize the City Treasurer,
Ormoc City to pay the salary of the City Intermediate
Teachers, Ormoc City corresponding for the month of July,
1953 inasmuch as the Primary Teachers have already collec-
ted their salaries in order to give justice and fairness
to the school teachers;

NOW THEREFORE, the Board, on motion of Councilor
Teotimo Ocubillo, seconded by Councilor Guillermo T.
Parrilla;

BE IT RESOVED, as it is hereby resolved, to authorize
the City Treasurer, Ormoc City to pay the salary of the
