RESOLUTION NO. 79

WHEREAS, the Presiding Officer, Honorable Isaki Larrasabal informed the Honorable Members of the Board that as per report made by the City Engineer, this City to the Secretary of Public Works and Communications, Manila, the havoc caused by the typhoon to the City of Ormoc amounted to P220,000.00;

WHEREAS, it has come to the knowledge of the members of the Board that an amount of P2,000,000.00 has been set aside in the Department of Finance under Republic Act No. 869, aid to the Provinces and Chartered Cities whose revenue collections have been greatly reduced due to the havoc and destruction wrought by typhoons and other calamities;

WHEREAS, be it known that the revenue collection of the City of Ormoc has been greatly reduced as a consequence of the disastrous conflagration that occurred on October 4, 1952, damaging properties amounting to P1,000,000.00 more or less;

WHEREAS, Councilor Guillermo T. Parrilla strongly suggested to the Honorable Body to respectfully request the Secretary of Finance, Manila, to allot to Ormoc City the amount of P220,000.00 in conformity with the report of the City Engineer, this City to the Secretary of Public Works and Communications, the same to be taken from out of the P2,000,000.00 as embodied under Republic Act No. 869, aid to Provinces and Chartered Cities whose revenue collections have been greatly reduced due to the havoc and destruction wrought by the typhoons and other calamities;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Hon. Secretary of Finance, Manila, to allot to Ormoc City the amount of P220,000.00 in conformity with the report of the City Engineer, this City to the Hon. Secretary of Public Works and Communications, Manila;

RESOLVED FURTHER, that the amount as above requested, be taken from out of the P2,000,000.00 as embodied under Republic Act No. 869, aid to Provinces and Chartered Cities whose revenue collections have been greatly reduced due to the havoc and destruction wrought by the typhoons, flood and other calamities;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Finance, Manila; Hon. Secretary of Public Works and Communications, Manila; Director of Public Works, Manila; City Engineer, Ormoc City; Hon. City Mayor, Ormoc City; City Treasurer, Ormoc City and the City Auditor, Ormoc City;
