RESOLUTION NO. 43

WHEREAS, due to the recent typhoons that lashed the Visayan Islands, the Pier of Ormoc City was heavily damaged;

WHEREAS, according to the City Engineer of Ormoc City in his annual report submitted to the Honorable Body on August 11, 1953, duly approved by the Division Engineer, the estimated expenses for the repair of said pier would amount to P25,000.00;

WHEREAS, due to the inability of the City Government of Ormoc to finance the repair of said Pier due to its precarious financial condition, Councilor Guillermo T. Parrilla suggested to the Honorable Body to respectfully request the Hon. Secretary of Public Works and Communications thru the Director of Public Works, Manila to give aid to the City of Ormoc from the National Fund the amount of P25,000.00 for the repair of the Ormoc Pier and Causeway;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Hon. Secretary of Public Works and Communications, Manila thru the Director of Public Works, Manila to give aid to the City of Ormoc the amount of P25,000.00 for the repair of the Ormoc Pier and Causeway, the same to be taken from the National Fund;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Public Works and Communications thru the Director of Public Works, Manila; to the City Mayor, City Engineer, City Treasurer, and the City Auditor, all of Ormoc City.

UNANIMOUSLY APPROVED.


