Treasurer of this City to deduct annually from the
revenues of this City, the sum of P125.00 for the
maintenance of each successful pump well, and P25.00
for the maintenance of each successful flowing well;
provided, that this resolution covers all the wells
now existing, as well as the wells herein requested
or approved;
