RESOLUTION NO. 92

WHEREAS, City Mayor, Iñaki Larrasabal, informed the Honorable Members of the Board that as per report made by the City Engineer, this City to the Secretary of Public Works and Communications, Manila the havoc caused by the typhoon to the City of Ormoc amounted to P220,000.00;

WHEREAS, it has come to the knowledge of the members of the Board that an amount of P2,000,000.00 has been set aside for the Department of Finance under Republic Act No. 869 as aid to the Provinces, Cities and Municipalities whose revenue collections have been greatly reduced due to the havoc and destructions wrought by typhoons and other calamities;

WHEREAS, in view of the said destruction and consequent reduction of the revenue of this City this Body believes that the City is entitled to aid with a view to alleviate its frustrate finances thoughts of soliciting the fraternal benevolence of the Honorable Secretary of Finance, Manila, to allot to Ormoc City the amount of P20,000.00 from the P2,000,000.00 set aside for this purpose, under Republic Act No. 869, as aid to Provinces, Cities and Municipalities;

NOW THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez seconded by Vice Mayor Maximo Malinao;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Honorable Secretary of Finance, Manila to allot to Ormoc City, the amount of P20,000.00;

RESOLVED FURTHER, that the amount as above requested, be taken from out of the P2,000,000.00 as embodied under Republic Act No. 869, aid to Provinces, Cities and Municipalities whose revenue collections have been greatly reduced due to the havoc and destruction wrought by typhoons, flood and other calamities;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Secretary of Finance, Manila; Hon. Secretary of Public Works and Communications, Manila; Hon. City Mayor, Ormoc City; City Treasurer, Ormoc and the City Auditor, Ormoc City.
