RESOLUTION NO. 24

WHEREAS, after the last registration day in Ormoc City, Oct. 3, 1953, Councilor Teotimo Ocubillo inform the Honorable Body that as per verified record in the office of the City Treasurer, it was found out that there was an increased in number of registered voters in five (5) precincts, 3 in the poblacion, Precinct No. 8, 12 and 13; 1 in Barrio Dolores, Precinct No. 23 and 1 in Barrio Patag, Precinct No. 23, which reached more than 300 hundred voters each;

WHEREAS, that during the election day it is feared that this registered voters may not be accommodated on reasonable time by the election inspectors in the precinct because of their great numbers and they might not be able to cast their votes in the proper time;

WHEREAS, in order to give facilities to registered voters in the precincts having large number of voters, the Municipal Board strongly suggested to the Commission on Election five additional precincts to answer the needs of the public in the aforementioned precincts;

NOW THEREFORE, the Board, on motion of Councilor Teotimo Ocubillo seconded by Vice Mayor Maximo Malinao;

BE IT RESOLVED, as it is hereby resolved, to respectfully request the Commission on Election, Manila, to add five (5) more precincts to the following viz to the number of registered voters here in shown:

"	23	Bo. Patag	- -	332	"
"	29	" Dolores	- -	482	"


