RESOLUTION NO. 97

Letter of Mr. Saturnino Pambid, Chief Survey Party
No. 12-A, Tacloban City, dated October 7, 1953, hereunder
quoted verbatim as follows:

Sir:

I have the honor to inform that a protest embodied
in Resolution No. 28 s. 1953 of the Municipal Council of
Albuera, dated September 15, 1953 to the effect that the
boundary line between Albuera and Ormoc City be a line
running from a broken cement post at sitio Taba-on to
Benabuyan post (presumably referring to M.B.M. No. 37 as
per B. L. Cadastral Survey No. 256 for Ormoc City) in-
stead of the line from Marabucol (M.B.M. No. 29 of Bureau
Cadastre which is equivalent to M.B.M. No. 36 of Ormoc
Cadastre).

In this connection, the matter is being referred to
the City Council of Ormoc City for any appropriate action
it may deem proper on the protest lodged by the Municipal
Council of Albuera, province of Leyte.

In the event that both parties concerned decide to
have an ocular inspection of the premises at sitio Taba-on
it is respectfully requested that the undersigned be noti-
fied and advised early enough of the date set forth and
agreed upon so as to enable him to go with the parties!

RESOLVED FINALLY, to furnish copy of this resolution each to the Chief, Survey Party No. 12-A, Bureau of Lands, Tacloban, City; the Municipal Council of Albueria, Leyte; the City Treasurer, Ormoc City and the City Auditor, Ormoc City and the City Engineer, Ormoc City.


