RESOLUTION No. 79

WHEREAS, the Municipal Board of Ormoc City in its
Regular Session held on August 15, 1953 passed resolution
No. 79 requesting the Honorable Secretary of Finance,
Manila to allot to Ormoc City the amount of P220,000.00
as typhoon aid;

WHEREAS, the Honorable Secretary of Finance in his letter dated
August 20, 1953 regretted that the allocation of typhoon
aid to Ormoc City can not be considered favorably inasmuch
as the request came too late;

WHEREAS, it is known that the revenue collection of the
City of Ormoc has been greatly reduced as a consequence of
the disastrous conflagration that occurred on October 4,
1952, damaging properties amounting to P1,000,000.00 more or
less;

WHEREAS, Councilor Teotimo Ocubillo strongly suggested
to request His Excellency, the President of the Philippines,
to ask a portion of P200,000.00 out of his P5,000,000.00
discretionary fund;

NOW THEREFORE, the Board on motion of Councilor Teotimo
Ocubillo seconded by Vice Mayor Maximo Malinao;

BE IT RESOLVED, as it is hereby resolved, to respect-
fully request His Excellency, the President of the Phil-
ippines to ask a portion of P200,000.00 out of his
P5,000,000.00 discretionary fund;

RESOLVED FINALLY, to furnish copy of this resolution
each to His Excellency, the President of the Philippines,
Manila; Hon. Secretary of Finance, Manila; Hon. Secretary
of Public Works, Manila; Hon. City Mayor, Ormoc City; the
City Engineer, Ormoc City; the City Treasurer, Ormoc City;
and the City Auditor, Ormoc City.
