RESOLUTION NO. 10

WHEREAS, the Election Day is fast approaching and it is very necessary and essential that there shall be peace officers to maintain order in every election precinct throughout the City of Ormoc;

WHEREAS, considering the fact that the Ormoc City Police Force is only 70; with this number many are utilized for traffic purposes;

WHEREAS, by virtue of Section 27, Article 8 of the Charter of Ormoc City, otherwise known as the Republic Act No. 179, Councilor Guillermo T. Parrilla strongly suggested to authorize the City Mayor to appoint Special Policemen and agents in such manner as he deems necessary for the maintenance of peace and order during the elections and during such period he deems necessary to cope with the situation;

NOW THEREFORE, the Board on motion of Councilor Guillermo T. Parrilla seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as it is hereby resolved, to authorized the City Mayor to appoint Special Policemen and agents in order to maintain peace and order during the elections;

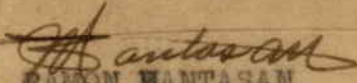
RESOLVED FURTHER, that the salary of a Special Policeman shall be appropriated out of the ₱9,000.00 discretionary fund of the City Mayor and shall receive a compensation of ₱2.00 a day during the whole period of their services;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, the President of the Philippines, Malacañan Palace, Manila; the Hon. Executive Secretary, Malacañan Palace, Manila; the Commission on Election, Manila; Hon. City Mayor, Ormoc City; the Chief of Police, Ormoc City; the City Treasurer, Ormoc City; the City Auditor, Ormoc City and the Register of Deeds, Ormoc City.

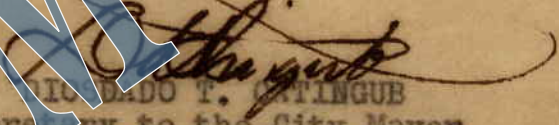
