In compliance with B.P.W. Circular, dated July 28,  
1953 in connection with the provision of Section 10 (d)  
of Republic Act No. 917, commonly known as the "Phil-  
ippine Highway Act of 1953", I have the honor to recom-  
mend hereunder the list of city streets and city roads  
which this Office believes should be included in the  
"National Aid" city road system, which amount to TWO  
HUNDRED FIFTY-ONE THOUSAND EIGHT HUNDRED TWENTY  
(\$251,820.00) PESOS, itemized as follows in accordance  
with the attached copies of Program of Works and Esti-  
mates:
