RESOLUTION NO. 11

Resolution requesting the City Council of Ormoc
City thru the Honorable Mayor to convert the Sitio
of Nueva Vista into a Barrio, hereunder quoted verbatim
as follows:

WHEREAS, the Sitio of Nueva Vista under the jurisdic-
tion of City of Ormoc is forming a community with around
five hundred inhabitants in thirty eight houses;

WHEREAS, it is the intention of this Sitio to give
help and support to the City of Ormoc;

WHEREAS, it is our moral duty to help the City give
a good representation by having more barrios;

WHEREAS, it is our moral obligation as a citizen in
this country to help financing the City where we are in;

BE IT RESOLVED, as it is hereby resolved, requesting
the City Council of Ormoc City thru the Honorable Mayor
to pass a resolution converting this Sitio of Nueva Vista
into a barrio the jurisdiction of which will be under the
discretion of that Honorable Body;

BE IT RESOLVED FURTHER, That a copy of the resolution
be furnished this Community for her record purposes;

Done in this Sitio of Nueva Vista, Ormoc City this
18th day of November 1953.

Signed by 26 persons residents of Sitio Nueva Vista.

NOW THEREFORE, the Board on motion of Vice Mayor
Maximo Malinao seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as it is hereby resolved, to create
the Sitio of Nueva Vista, Ormoc City into a barrio com-
prising the Sitio of Bagaobao, Cabaon-an and Cabadiangan;

RESOLVED FINALLY, to furnish copy of this resolution each to the Speaker, House of Representatives, Manila; Representative, 2nd District of Leyte, Manila; to the barrio people of Nueva Vista; the Hon. City Mayor, Ormoc City; the City Treasurer, Ormoc City and the City Auditor, Ormoc City.
