RESOLUTION NO. 111

WHEREAS, it has come to the attention of the Honorable Members of the Board that a telegram has been received from Manila addressed to Mr. Manuel Moriles, Acting Chief Clerk in the Office of the City Engineer, Ormoc City, as quoted: "12 PM 12 VX AM 12 COLLECT MANILA MANUEL MORILES ORMOC CITY (par.) CLOSE YOUR ACCOUNTS SUSPEND ALL WORK PD EXPENDITURES EXCEPT CLERICAL (par.) (sig.) FERNANDO";

WHEREAS, due to the suspension of all public-works employees, there cause untold hardships and financial distress; the repair of highway bridges ceased which caused hazards and hampered flow of traffic; garbage disposal endangered the health and sanitary conditions of this city;

WHEREAS, inasmuch as the sender of the above telegram is not identified by this Board, Councillor Guillermo T. Parrilla strongly suggested that the Board respectfully request the Chief of Telecommunication Service, Ormoc City, to trace the sender of that telegram as above quoted;


NOW THEREFORE, The Board, on motion of Councillor Guillermo T. Parrilla seconded by Councillor Esteban Conejos;
