RESOLUTION NO. 11

WHEREAS, it has come to the attention of the Honorable Municipal Board that the policemen who were relieved of their services without the benefit of accrued vacation and sick leave;

WHEREAS, the policemen who were relieved then collected their accrued vacation and sick leave after having resigned from their posts, and as claimed by Councilor Alvarez I. Gutierrez those policemen were benefited by their accrued leave without even their asking and without appropriation, Councilor Mateben C. Conojos strongly suggested that the policemen who were relieved in 1949 be credited their accumulative leave and to effect an appropriation of the sum of THREE THOUSAND PESOS (\$3,000.00) to be reverted from the balance of the City Mayor's Discretionary Fund to be distributed proportionately to those who are entitled to their accrued vacation and sick leave.

THE BOARD, The Board, on motion of Councilor Mateben C. Conojos seconded by Vice-Mayor Mariano Malinas;

IT IS RESOLVED, as it is hereby resolved, to appropriate the sum of THREE THOUSAND PESOS (\$3,000.00) to be reverted from the City Mayor's Discretionary Fund to be distributed proportionately to those policemen who are entitled to accrued vacation and sick leave after having been relieved in 1949.


RESOLVED FURTHER to furnish copy of this Resolution each to the Hon. Secretary of Finance, Manila; the Honorable Executive Secretary, Office of the President of the Philippines, Manila; the Hon. City Mayor; the City Treasurer, and the City Auditor, all of Cibao City.


