WHEREAS, during the widening of the City Streets,
the land of Aboitiz & Co., Ormoc Agency, this City
has been affected with an area of 139.38 square meters
along Rizal and Burgos Streets under Title Nos. 699 &
701; Lot Nos. 4, 5 & 7 as recommended and verified by
the City Engineer;

WHEREAS, Councilor Emilio C. Penserga strongly
suggested that a sum of P3,580.00 be appropriated to be
paid to Mr. Conrado Ratcliffe, Manager of the Aboitiz
& Co., Inc., Ormoc Agency, for the total number of
square meters utilized by the City Government in the
widening of the City Streets as above stated;

NOW THEREFORE, the Board, on motion of Councilor
Emilio C. Penserga seconded by Councilor Teotimo Ocuillo;

BE IT RESOLVED, as it is hereby resolved, to appro-
priate the sum of P3,580.00 to be paid to Mr. Conrado
Ratcliffe, Manager of Aboitiz & Co., Inc., Ormoc Agency,
for the land affected by the widening of the City Streets;


RESOLVED FURTHER, that the amount of P3,580.00 be

Manager, Aboitiz & Co., Inc., Ormoc Agency, Ormoc City.


