RESOLUTION NO. 16

Letter of Engr. Placido Enecio, dated February 26, 1954, addressed to the Municipal Roard, Ormoc City, here-under quoted verbatim as follows:

Termoc City February 26, 1954

The Honorable Municipal Board Ormoc City

Sirs:

Mith reference to your letter of February 24th, I nave the honor to advise you that I am willing to construct the Public Market Tiendas under either of the two items contained in my proposal sheet, to wit:

- 1. For the construction of Public Market Tiendas (double) 7 bays, 4.00 x 8.00 complete as per plans and specifications using old footings for \$10,600.00 to be completed in 50 working days.
- Same as item 1 but without ceiling, partition and siding using old footings for ₱7,900.00 to be completed in 30 working days.

It is respectfully requested that item 2 (Open Market Tiendas) for \$7,900.00 be awarded to me for the following reasons:

- 1. At the time I prepared my estimate about half a year ago, price of lumber, particularly T&G boards for ceiling, partition and siding, was then lower than the current price. Hence, the risk of losing under item 1 is greater.
- 2. The amount of capital I can possibly invest now is less than when I won the bid last August 29, 1953 because part of my capital will be diverted to another contract in Merida, Leyte which I expect to start next week. Item 1 calls for a bigger capital as it is a bigger contract.
- 3. Ceiling, partition and siding can be constructed individually by the prospective stallholders as has been the practice in other stalls of the

market. A savings in market collection is effected if these stalls are made available for occupancy at the earliest possible time.

However, if the Honorable Municipal Board, for one one reason or another, will turn down this request I will have no other alternative but to reiterate my willingness to accept whichever item of my proposal will be awarded to me.

It is futher requested that the market supervisor be instructed to advise the present occupants of the premises to vacate and clear the site of their present temporary stores a week before commencement of our construction and that a good space near the building site be assigned to me for storage of building materials.
