make necessary representations so that the prisoner concerned  
can be admitted into the government hospital at Baybay, Leyte,  
or any civilian hospital.

Agapito Hermias is detained for Qualified Theft of Large Cat-  
tle in Crim. Case No. 3304 filed before the Municipal Court  
of this city. Case is pending preliminary hearing.
