VETO

VETO ON RESOLUTION NO. 59, CURRENT SERIES, OF THE HONORABLE MUNICIPAL BOARD, ORMOC CITY, PURSUANT TO SECTION 14, ART. III, REP. ACT. NO. 179.

Pursuant to the provisions of Section 14, Art. III of Republic Act No. 179, otherwise known as the Charter of Ormoc City, I veto, as it is hereby vetoed, Res. No. 59, current series, of the Konoruble Municipal Board, Ormoc City, on the following grounds, to wit:
