
VETO ON RESOLUTION NO. 59, CURRENT SERIES,
OF THE HONORABLE MUNICIPAL BOARD, ORMOC
CITY, PURSUANT TO SECTION 14, ART.
III, REP. ACT. NO. 179.

Pursuant to the provisions of Section 14, Art. III, of Republic Act No. 179, otherwise known as the Charter of Ormoc City, I veto, as it is hereby vetoed, Res. No. 59, current series, of the Honorable Municipal Board, Ormoc City, on the following grounds, to wit:

- 1.- This is unfair and unnecessary because it is really true that Chief Ciriaco Porcadilla is not a reserved officer;
- 2.- The rank mentioned in his designation as Acting Chief of Police for Ormoc City was not asked nor suggested by him but was voluntarily indicated only by the appointing power; and,
- 3.- He can adjust his rank from Major to Capt. if the latter rank is really prescribed by the Board for a Chief of Police for Ormoc City.
