RESOLUTION NO. 64

WHEREAS, Councilor Guillermo T. Parrilla suggested to the Hon. Body to amend Sec. 1, Ordinance No. VII, adopted in Resolution No. 109, series of 1952, to read as follows:

"SECTION I. Blowing of horns of trucks, automobiles and other motor vehicles is prohibited after ten o'clock in the evening and before six o'clock the following morning;"

"Conductors and drivers of passenger cars and/or automobiles and other TPU vehicles are prohibited from shouting at the top of their voices in such a way that it will disturb the peace and tranquility of the inhabitants within the period set forth in Par. 1;"

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Esteban C. Conejos and Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to amend Sec. 1, Ordinance No. VII, adopted in Resolution No. 109, series of 1952, to read as follows:

"SECTION I. Blowing of horns of trucks, automobiles and other motor vehicles is prohibited after ten o'clock in the evening and before six o'clock the following morning;"


