RESOLUTION NO. 65

WHEREAS, Councilor Guillermo T. Parrilla brought to the attention of the Hon. Members of the Board that the salaries of the city intermediate teachers of Ormoc City is making a big drain in the city coffers, thus resulting to the incurrence of deficits;

WHEREAS, the Councilor further manifested that in order to minimize the incurrence of deficits from time to time, it would be proper for the Hon. Members of the Board to pass a resolution requesting the Hon. Domingo Veloso, to propose a bill seeking amendment of Republic Act No. 179, otherwise known as the Charter of Ormoc City, nationalizing the city intermediate schools of the City of Ormoc;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Teotimo Ocubillo and Jorge S. Tan;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Hon. Domingo Veloso, House of Representatives, Manila, to propose a bill seeking amendment of Section 85 of Republic Act No. 179, otherwise known as the Charter of Ormoc City, nationalizing the city intermediate schools of said city;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Domingo Veloso, House of Representatives, Manila; Committee on Chartered Cities, House of Representatives, Manila; the Hon. City Mayor; City Treasurer; City Auditor and the District Supervisors, Ormoc I & II, all of Ormoc City.
