RESOLUTION NO. 66

Letter of the City Health Officer, Ormoc City, dated
March 17, 1954, hereunder quoted verbatim as follows:

"March 17, 1954

"The Honorable City Council
Ormoc City

S i r s;

Having learned from the Bookkeeper of the Treasurers
office of the City that there is a total of ₱1,075.29
Sweepstake aid to the City up to the present time. And
that deducting the salary of the Dental Attendant of the
City Dentist for 4 months from March-June 30, 1954 at ₱70.00
a month making a total of ₱280.00, there is still a balance
of ₱795.29.

It is respectfully requested from the Honorable City
Council that the amount of ₱795.29 be appropriated for the
purchase of surgical equipments such as surgical scissors,
surgical knives, hemostatic forceps, kidney basins, ins-
trument trays and alcohol stoves for the barrio dispensaries
at Bos. Valencia, Curva, Simaigan and Ipil to the amount of
₱500.00 and for traveling expenses of the Assistant City
Health Officer, City Dentist and dental attendant and also
the Public Health Nurse who are making weekly consultations
and treatments in the barrio dispensaries at Bos. Valencia,
Curva, Simaigan and Ipil to the amount of ₱295.29.

It is hoped that Honorable Body will favorably consider
this appropriation requested.

the City Health Department personnel;
