Valencia, Curva, Simañgan and Ipil to the amount of \$\mathbb{P}50.00\$ and for traveling expenses of the Assistant City dealth Officer, City Dentist and dental attendant and also the Public Health Nurse who are making weekly consultations and treatments in the barrio dispensaries at Bos. Valencia, Curva. Simañgan and Ipil to the amount of \$\mathbb{P}295.29\$. Curva, Simangan and Ipil to the amount of \$295.29.
