RESOLUTION NO. 68

WHEREAS, Councilor Teotimo Ocubillo informed the Hon. Members of the Board that Mr. Petronilo Sacnanas, appointed by the Hon. Actg. City Mayor as barrio lieutenant of Catayum took possession of the corn produce of a government land in said barrio from Mr. Miaga, also a barrio lieutenant duly appointed by a City Councilor;

WHEREAS, Councilor Ocubillo manifested that in order to avoid occurrence of dispute and misunderstanding between Mr. Sacnanas and Mr. Miaga, it would be better to require Mr. Sacnanas to return the produce in question to Mr. Miaga so that Mr. Miaga could report the same to the City Treasurer of Ormoc City;

NOW THEREFORE, the Board, on motion of Councilor Teotimo Ocubillo, seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved, to require Mr. Petronilo Sacnanas to return the produce of the government land of Catayum to Mr. Miaga so that the latter could report the same to the City Treasurer of Ormoc City.

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor; City Treasurer, Ormoc City; City Auditor, Ormoc City; Mr. Petronilo Sacnanas, Bo. Catayum, Ormoc City and to Mr. Miaga, Bo. Catayum, Ormoc City.

VETO ON RESOLUTION NO. 68, CURRENT SERIES, OF  
THE HONORABLE MUNICIPAL BOARD, ORMOC CITY  
PURSUANT TO SECTION 14, ART. III, OF  
REPUBLIC ACT NO. 179

Pursuant to Section 14, Art. III of Republic Act No. 179, otherwise known as the Charter of Ormoc City, I veto, as it is hereby vetoed, Res. No. 68, current series, of the Honorable Municipal Board, Ormoc City, on the following grounds, to wit:

- 1.- Mr. Petronilo Sacnanas has the right to take possession of the corn produce of the government land of said barrio for he is the present barrio lieutenant.
- 2.- That the resolution will create more confusion.
- 3.- That the resolution is not within the legal capacity of the Board to enact because it is an encroachment of the power of the City Mayor who has full control and supervision over barrio lieutenants.
