RESOLUTION NO. 74

WHEREAS, during the term of duty of Captain Arcadio S. Lozada in Ormoc, supervising the Police Department of this city, much improvement has been made on that department, in discipline, training, organization, etc;

WHEREAS, Captain Arcadio S. Lozada, has proved himself capable in giving peace and order to the city of Ormoc by putting himself absolutely apart from political control and doing his duty for public good;

WHEREAS, unofficial information reaching this Body states that a plan is underway to withdraw Captain Lozada from Ormoc City;

WHEREAS, the Municipal Board, who by authority of the City Charter (Republic Act 179) is empowered to keep efficient police force and that this Body believes that Captain Lozada's presence is still necessary in Ormoc for further training of the police force and for the maintenance of peace and order here;

NOT THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to officially express the appreciation of the Municipal Board of the services rendered by Captain Arcadio S. Lozada, Officer-in-Charge, Police Department, Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; Congressman Domingo Veloso, House of Representatives, Manila; Captain Arcadio S. Lozada, Police Department, Ormoc City; the Hon. City Mayor; Ormoc City; City Treasurer, Ormoc City; City Auditor, Ormoc City; City Attorney, Ormoc City; City Engineer, Ormoc City; Fire Chief; Ormoc City; Municipal Judge, Ormoc City; City Health Officer, Ormoc City.


