RESOLUTION NO. 79

WHEREAS, be it known that effective the end of the school year 1953-1954 all secondary schools outside Tacloban in the Division of Leyte will be considered closed unless authority is granted by the General Office for their reopening before June 14, 1954 in accordance with Circular-letter, dated April, 1954 of the Division Superintendent of Schools for the Province of Leyte;

WHEREAS, said Circular-letter provides that "Any municipality desiring to have its secondary school or classes reopened should submit to this Office its request on or before May 5, 1954", with all the information required in said circular-letter, one of which is a resolution of the Municipal Council authorizing the reopening of the school;

WHEREAS, the teacher-in-charge of Ormoc City High School and all the faculty members, being present during the deliberation manifested that they will do their best to comply with the requirements set forth in the circular-letter above-mentioned and further suggested to the Hon. members of the Board to pass a resolution authorizing the reopening of the Ormoc City High School in compliance with requirement No. 1 of the circular-letter;

NOW THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to authorize the reopening of the Ormoc City High School for the school year 1954-1955;

RESOLVED FINALLY, to furnish copy of this resolution each to the Division Superintendent of Schools, Tacloban City; the Hon. City Mayor; City Treasurer; City Auditor; and the Teacher-In-Charge, Ormoc City High School, all of Ormoc City.
