RESOLUTION NO. 79-A

WHEREAS, be it known that one of the requirements set forth in the circular-letter of the Division Superintendent of Schools of Leyte, dated April, 1954 for secondary schools outside Tacloban is the acquisition of a school site which should be at least eight hectares, if possible; within the poblacion;

WHEREAS, to date, the Ormoc City High School has not acquired a piece of land in the poblacion for its school site;

WHEREAS, in order to comply with the requirement as set forth in the circular-letter above-mentioned, the Hon. Members of the Board unanimously agreed to authorize the City Mayor of Ormoc City to inquire from Mr. Jaanito Yap as to the possibility of acquiring ten (10) hectares of land, eight (8) hectares of which will be utilized by the Ormoc City High School and two (2) hectares will be utilized by the City Government, so that the Municipal Board can make the necessary appropriation in case there is a way of acquiring the same;


NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilors Emilio C. Penserga and Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to authorize the City Mayor of Ormoc City to inquire from Mr. Juanito Yap as to the possibility of acquiring ten (10) hectares of land, eight (8) hectares of which will be utilized by the Ormoc City High School and two (2) hectares will be utilized by the City Government, so that the Municipal Board can make the necessary appropriation in case there is a way of acquiring the same;

RESOLVED FINALLY, to furnish copy of this resolution each to the Division Superintendent of School, Tacloban City; the Hon. City Mayor; City Treasurer; City Auditor and the Teacher-In-Charge, Ormoc City High School, all of Ormoc City.




