RESOLUTION NO. 82

WHEREAS, be it known that the Municipal Board, this city, in its regular session held on April 30, 1954, passed Resolution No. 80 protesting the appointment of Atty. Teodulo C. Tandayag as Vice Mayor of Ormoc City;

WHEREAS, Councilor Usualdo F. Laguitan, the mover of the Resolution (No. 80) above-mentioned manifested before the Hon. Members of the Board that the protest he presented did not carry with it an objection to the personality or a bit of doubt on the capability of the newly appointed Vice Mayor of Ormoc City but because Atty. Teodulo C. Tandayag happens to be not a resident of the City of Ormoc;


WHEREAS, Councilor Usualdo F. Laguitan further expressed his intention to recall the protest he presented contained in Resolution No. 80, c.s., on the appointment of Atty. Teodulo C. Tandayag as Vice Mayor of Ormoc City;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Jorge S. Tan;


BE IT RESOLVED, as is hereby resolved, to recall the motion of Councilor Usualdo F. Laguitan protesting the appointment of Atty. Teodulo C. Tandayag as Vice Mayor of Ormoc City, contained in Resolution No. 80, c.s. of the Municipal Board;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; Hon. Domingo Veloso, H.R., Manila; the Hon. City Mayor; City Treasurer; City Auditor; City Attorney City Engineer; City Chief of Police; Municipal Judge, Chief of Fire Department; City Health Officer, all of Ormoc City.
