RESOLUTION NO. 83

WHEREAS, Councilor Usualdo F. Laguitan manifested before the Hon. Members of the Board that in order to balance the city budget and to improve the financial condition of the City, there are two main points to be considered; (a) increase in income and (b) increased amount of expenditures;

WHEREAS, Councilor Laguitan further manifested that the City Treasurer informed him that there are fees which are unreasonable and needs modification and there are also fees which are not yet fixed by an ordinance and licenses already listed but not yet in the Charter;

WHEREAS, Councilor Usualdo F. Laguitan suggested to the Hon. Members of the Board to respectfully request the City Treasurer, Ormoc City to furnish the Municipal Board:

- (a) List of amount of license fees already fixed by previous ordinance
- (b) List of trade or occupation listed in Republic Act No. 179, otherwise known as the Charter of Ormoc City, licenses of which are not yet fixed by ordinance; and
- (c) City Treasurer's recommendation on modifications, if any, on list (a) above and proposed fees on those in (b) above;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to respectfully request the City Treasurer, Ormoc City, to furnish the Municipal Board:


- (a) List of amount of license fees already fixed by previous ordinance
- (b) List of trade or occupation listed in Republic Act No. 179, otherwise known as the Charter of Ormoc City, licenses of which are not yet fixed by ordinance; and
- (c) City Treasurer's recommendation on modifications, if any, on list (a) above and proposed fees on those in (b) above;
