Ormoc On 31st December 1953, Cpl. Ulpiano Calderon and Det.
Andres Gareñana, all members of the Ormoc City Police
Department, were sent to Cebu City and nearby towns to
follow up and apprehand if found one Victor Arcuino, who
was charged of Slight Physical Injuries in Criminal Case
No. 3348.

While in the performance of their official mission in Cebu, Cpl. Ulpiano Calderon was attacked of a severe sto-mach trouble, thus causing him to return to station and reported his sickness, in which case he was advised to consult the doctor. On January 11, 1954, he was hospitalized and operated of Apendectomy by Dr. Alvaro Gutierrez.

It is therefore requested that Cpl. Ulpiano Calderon, who contacted his illness in line of duty, be helped financially to enable him to pay his obligations to the hospital.

Cpl. Ulpiano Calderon is a poor-married man with a big family and is the only source of their daily bread. Up to the present, Cpl. Ulpiano Calderon is still weak due to his operation and yet because of necessity and poverty, he is still in hot pursuit of a job to make both ends meet.
