RESOLUTION NO. 93

WHEREAS, Councilor Usualdo F. Laguitan informed the Hon. Members of the Board that he was advised by the Market Superintendent, Ormoc City that there are stalls in the newly constructed market building that are not yet occupied because the ordinance provides for proper bidding to the occupancy of these stalls and that no Committee on Bids for the award of these stalls had been created by the Municipal Board;

WHEREAS, Department of Finance Order No. 32, dated November 29, 1946, provides for a Market Committee to compose the City Treasurer as Chairman; City Mayor's Representative; Municipal Board's representative; City Attorney's representative; Department of Finance Representative and the Market Superintendent as members thereof; functions of which are to conduct drawing of lots and opening of bids in connection with the adjudication of vacant or newly created stalls or booth in the City;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to create a Market Committee for the City of Ormoc to compose the following:

functions of which are to conduct drawing of lots and opening of bids in connection with the adjudication of vacant or newly created stalls or booth in the City;

BE IT RESOLVED FURTHER, that the Market Committee as above created proceed immediately to open the vacant stalls to bidding in accordance with existing ordinance of this City regarding the stalls of the newly constructed building;


RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor; City Treasurer; City Auditor; City Attorney; Market Superintendent; all of Ormoc City and to the Department of Finance, Manila.
