RESOLUTION NO. 94

WHEREAS, be it known that the Judge of the Court of First Instance of Maasin, Leyte will come to Ormoc City and hold sessions beginning on or about the middle of June, 1954;

WHEREAS, the office supplies to be used by said Court will be requisitioned through the Municipal Judge of Ormoc City;

WHEREAS, Councilor Esteban C. Conejos suggested to the Hon. Members of the Board to appropriate the amount of P350.00 for the purchase of office supplies for the Municipal Court of Ormoc City, the same to be used by the Court of First Instance from on or about the middle of June, 1954 up to the time said Court leaves Ormoc City for Maasin, Leyte;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P350.00 for the purchase of office supplies for the Municipal Court of Ormoc City, the same to be used by the Court of First Instance from on or about the middle of June, 1954 up to the time said Court leaves Ormoc City for Maasin, Leyte; the same amount to be taken from funds not otherwise appropriated;
