RESOLUTION NO. 92

WHEREAS, Councilor Esteban C. Conejos informed the Presiding Officer that the Municipal Board in its special session held on March 30, 1954 passed and approved resolution numbered 61 respectfully requesting then Acting City Mayor Roberto B. Almaden to let the barrio tenientes appointed by the City Councilors stay pending the receipt of the legal opinion of the Secretary of Justice as to who is vested with power to appoint barrio tenientes, whether the City Councilors or the City Mayor;

WHEREAS, said resolution numbered 61, s. 1954 was vetoed by then Acting City Mayor Roberto B. Almaden for grounds stated in his veto;

WHEREAS, Councilor Conejos strongly suggested to the Hon. Members of the Board to pass a resolution respectfully requesting Vice Mayor & Acting City Mayor Rafael M. Mejia to let the barrio tenientes appointed by the City Councilors stay as barrio tenientes pending receipt of the legal opinion of the Hon. Secretary of Justice;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to respectfully request the Vice Mayor & Acting City Mayor to let the barrio tenientes appointed by the City Councilors stay as barrio tenientes pending receipt of the legal opinion from the Hon. Secretary of Justice;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor; City Treasurer and the City Auditor, all of Ormoc City.

CARRIED. 5 in favor. 1 abstention.
