We wish to invite your attention to our letters dated July 1, 1953 and January 29, 1954, regarding the above pre-war loan of your City, with the defunct Agricultural and Industrial Bank.

If the project constructed with the proceeds of the said loan was destroyed during the last war, please submit to us the documents required in our said letter of July 1, 1953 so that we may determine whether or not the loan may be condoned pursuant to the provisions of Republic Act No. 839.

It is requested that the above requirement be submitted to us not later than May 31, 1954, otherwise, we will proceed with the collection of the annual amortizations due by draft as indicated in the schedule.
