RESOLUTION NO. 127

WHEREAS, the City Government (then Municipality of Ormoc) had a pre-war loan for the gravity waterworks in the amount of NINETY-THREE THOUSAND TWO HUNDRED TWENTY-NINE PESOS AND NINETY-THREE CENTAVOS (P93,229.93) from the Agricultural and Industrial Bank succeeded by the Rehabilitation Finance Corporation;

WHEREAS, four (4) annual amortizations of said loan which were due in 1949, 1950, 1951, and 1952, at the aggregate total of THIRTY-TWO THOUSAND NINE HUNDRED SEVENTEEN-PESOS AND SIXTY-EIGHT CENTAVOS (P32,974.68) were already paid, leaving a balance of SIXTY EIGHTH TWO HUNDRED FIFTY-FIVE PESOS AND TWENTY-FIVE CENTAVOS (P68,255.25);

WHEREAS, the distribution and transmission line of the waterworks were destroyed during the war from May to December 1944 due to the bombing and shelling and water pipes and valves were stolen by unknown persons;

WHEREAS, the extension of the damage was estimated 90% of the system and to reach not less than P65,000.00 as estimated by the City Engineer;

WHEREAS, for obvious reasons no war damage claim was made on such damage and, therefore, no award was made and no amount was received for same;

WHEREAS, as a result of the bombing and shelling, the cracking of the reservoir and intakes renders same practically useless;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to petition the Rehabilitation Finance Corporation that the above pre-war loan of the government of Ormoc for the gravity waterworks system be condoned;

RESOLVED FURTHER, that the Hon. City Mayor be authorized by the Board to certify the extent of destruction of the water system of Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the General Manager, RFG, Manila; the Hon. City Mayor; City Treasurer; City Auditor and the City Engineer, all of Ormoc City.

6. Remarks:

The distribution system and transmission lines were badly damaged due to the bombing and shelling; pilferage of pipes, water meters and valves was heavy. There being no water, the walls and floor of the reinforced concrete reservoir cracked due to the heat of the sun.

Repairs were undertaken between the period of April 16, 1946 and August 21, 1947 and the system was again put into operation on Sept. 1, 1947.
