RESOLUTION NO. 109

WHEREAS, be it known that to date the City Government of Ormoc has not furnished a building to house the Court of First Instance, 13th Judicial District, 5th Branch) at Ormoc City;

WHEREAS, Governor Bernardo Torres of the Province of Leyte, being present during the deliberation informed the Hon. Members of the Board that the maintenance of the Court of First Instance in a City outside the Capital City will be borne by the City - 1/3 share, and the Province - 2/3 share;

WHEREAS, the Hon. Governor having been informed of the present precarious financial condition of the City Government of Ormoc manifested that the City will be given to bear only the expenses for the building rentals and equipment and supplies which will mean only about P7,000.00 a year;

WHEREAS, the Hon. Members of the Board unanimously agreed to take care only of the expenses for the building rentals and equipment;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, that the expenses for the building (rental) and equipment of the Court of First Instance in the City of Ormoc (13th Judicial District, 5th Branch) be shouldered by the City Government of Ormoc;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. Provincial Governor of Leyte, Tacloban City; the Hon. Provincial Board of Leyte, Tacloban City; the Hon. City Mayor; City Treasurer; City Auditor; all of Ormoc City.
