RESOLUTION NO. 112

WHEREAS, on manifestation of Councilor Esteban C. Conejos to appropriate the amount of P6,500.00 as initial payment for the construction of the 10,000-peso Court-house and Provincial Jail the same amount to be incorporated in the fiscal budget for 1954-1955;

WHEREAS, Councilor Alvaro I. Gutierrez suggested that the construction must be made to public bidding under the supervision of the City Engineer, Ormoc City, who will submit a plan for the building to be constructed along Burgos Street adjacent to the lot where the Mabuhay Theater now stands;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P6,500.00 as initial payment for the construction of a 10,000-peso Courthouse and Provincial Jail the same amount to be incorporated in the fiscal budget for 1954-1955;

BE IT FURTHER RESOLVED, that the construction of said Courthouse and Provincial Jail be made to public bidding supervised by the City Engineer, Ormoc City, who will submit a plan for the building to be constructed along Burgos street adjacent to the lot where the Mabuhay Theater now stands;




