RESOLUTION NO. 114

WHEREAS, the Court of First Instance, 5th Branch of the 13th Judicial District situated at Ormoc City has been operating without an office of its own;

WHEREAS, Councilor Alvaro I. Cutierrez, in his capacity as Member of the Committee on Survey for a Countrouse, has informed the Board of Mr. Manolo Van's house on Bonifacio Street, this City, as the best building for said Courthouse;

whereas, the owner of the house, Ar anolo Tan, has signified his willingness to remodel said house at the expense of the City Government which will be credited to the rentals of said house at the rate of ONE HOUSE D TWENTY-FIVE PESOS (P125) a month and that remodelling be made according to the specifications of the Homorable Judge and the City Engineer of Ormoc City

While the owner of the house, Mr. Manolo Tan, has further signified his willingness to refund the amount advanced him to the reutals accruing to the building without interest, in case of fire;

NOW, TEREFORE, the Board on motion of Councilor Alvaro I. Julian ez, seconded by Councilor Esteban C. Conejos:

DE IT RESOLVED, as is hereby resolved, to appropriate the amount of THREE THOUSAND PESOS (\$\overline{P}\overline{3}\)000) from the current appropriation to be expended as rentals for two (2) years at the rate of ONE HUNDRED TWENTY-FIVE PESOS (\$\overline{P}\overline{1}\)25) a month and remodelling of the building, according to the specifications of the Honorable Judge and the City Engineer, including the provincial jail, the ground and the lot surrounding the building to be used for proper fencing and placing of security contrivance and that the house of Mr. Manolo Tan on Bonifacio Street, Ormoc City, be contracted for the purpose;

RESOLVED FURTHER, to have the City Attorney of Ormoc prepare the Contract of Lease with the stipulation as deliberated by this Body that should the building be burned, the owner, Mr. Manolo Tan, will refund the amount advanced minus the rentals accruing to the building without interest;
