RESOLUTION NO. 120

WHEREAS, Councilor Esteban C. Conejos brought the attention of the Honorable Body that the bicycle for official use of the Office of the Municipal Board under the care, use and custody of the Messenger is out of order;

WHEREAS, Councilor Esteban C. Conejos strongly suggested that the Honorable Body should appropriate the amount of P55.50 to pay Mr. Daniel Sacay who repaired the said bicycle which the Municipal Board of Ormoc City urgently need;

BE IT RESOLVED, as is hereby resolved to appropriate the amount of P55.50 to pay Mr. Daniel Sacay who repaired the bicycle aforementioned; the same being urgently needed as above stated;

RESOLVED FURTHER, that the amount above appropriated be taken from the traveling expenses of the City Councilors;


RESOLVED FURTHERMORE to inform the authorities concerned to dispense with the required public bidding in the repair of the bicycle aforementioned to avoid unnecessary delay, said bicycle, being urgently needed to serve the best interest of the Honorable Body to accomplish with dispatch the errand of the Members of the Board in connection with their official business and delivery of messages thru its messenger.
