RESOLUTION NO. 157

WHEREAS, the City Highway Engineer, Ormoc City, in his letter dated September 11, 1954, addressed thru the Hon. City Mayor to the Hon. Mpl. Board, Ormoc City, requested that a resolution be passed respectfully requesting the Liberty Wells Association, Manila, to donate an allotment for the construction of artesian wells in the barrios of Ormoc City that have no artesian wells yet because residents of said barrios are presently using unsafe drinking water;

NOW THEREFORE, the Board, on motion of Councilor Porfirio Ayuyao, seconded by Councilor Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, to respectfully request the Liberty Wells Association, Manila, to donate an allotment for the construction of artesian wells in the following barrios of Ormoc City:
