RESOLUTION NO. 138

DESIGNATING THE CITY ROADS AND BRIDGES ACTUALLY
SERVING MOTOR VEHICULAR TRAFFIC UPON WHICH THE
NATIONAL AID FOR MAINTENANCE SHALL BE SPENT.

WHEREAS, in compliance with Section 9(b) of Republic
Act No. 917, the Hon. Members of the Municipal Board pre-
sent unanimously agreed to designate the streets and
bridges listed hereunder as the ones which the National
Aid to this City from the Highways Special Fund for the
maintenance of existing and unabandoned city roads and
bridges, plus the counterpart maintenance fund appropriated
by this Body for said purpose, shall be spent;

1. Ormoc-Merida City Road.....	14.420 kms.
2. All City Streets.....	8.072 kms.
Total.....	22.492 kms.

NOW THEREFORE, the Board, on motion of Councilor
Guillermo T. Parrilla, seconded by Councilor Alvaro I.
Gutierrez;

BE IT RESOLVED, as is hereby resolved, to designate
the streets and bridges listed above as the ones on which
the National Aid to this city from the Highways Special
Fund for the maintenance of existing and unabandoned
city roads and bridges, plus the counterpart maintenance
fund appropriated by this Body for said purpose, shall
be spent;

RESOLVED FURTHER, to request the City Engineer, to
prepare an adequate maintenance program for said roads
and an estimate of costs necessary for such maintenance
program, forward the same to the Director of Public Works
for approval, and after such approval, submit the same to
this Body for the appropriation of the required Counter-
part Maintenance Fund;

RESOLVED FINALLY, to furnish copy of this resolution
each to the Hon. City Mayor; City Treasurer; City Auditor
and the City Engineer, all of Ormoc City.
