RESOLUTION NO. 2

WHEREAS, be it known that there are at present 10  
insular prisoners that will be sent to Muntinlupa to  
be escorted by 4 policemen of Ormoc City;

WHEREAS, the appropriation for travel and transpor-  
tation of the Office of the Chief of Police had already  
been exhausted;

WHEREAS, Councilor Porfirio Ayuyao suggested to the  
Hon. Members of the Board present to appropriate the amount  
of P440.00 for the traveling expenses of the 10 insular  
prisoners from Ormoc to Manila-to Muntinlupa and of 4  
police escorts from Ormoc to Manila-to Muntinlupa and  
return to Ormoc, the same amount to be taken from the un-  
appropriated balance of the current fiscal budget;

NOW THEREFORE, the Board, on motion of Councilor  
Porfirio Ayuyao, seconded by Councilor Jorge S. Tan;

BE IT RESOLVED, as is hereby resolved, to appropriate  
the amount of P440.00 for the traveling expenses of the  
10 insular prisoners from Ormoc to Manila-to Muntinlupa  
and of 4 police escorts from Ormoc to Manila-to Muntinlupa  
and return to Ormoc, the same amount of P440.00 to be taken  
from the unappropriated balance of the current fiscal budget;

RESOLVED FINALLY, to furnish copy of this resolution  
each to the Hon. City Mayor; City Treasurer; City Auditor;  
and the Chief of Police, all of Ormoc City.
