RESOLUTION NO. 2

WHEREAS, be it known that there are at present 10  
insular prisoners that will be sent to Muntinglupa to  
be escorted by 4 policemen of Ormoc City;

WHEREAS, the appropriation for travel and transpor-  
tation of the Office of the Chief of Police had already  
been exhausted;

WHEREAS, Councilor Porfirio Ayuyao suggested to the  
Hon. Members of the Board present to appropriate the amount  
of ₱440.00 for the traveling expenses of the 10 insular  
prisoners from Ormoc to Manila-to Muntinglupa and of 4  
police escorts from Ormoc to Manila-to Muntinglupa and  
return to Ormoc, the same amount to be taken from the un-  
appropriated balance of the current fiscal budget;


NOW THEREFORE, the Board, on motion of Councilor

CARRIED UNANIMOUSLY.


