WHEREAS, the case of the death of sail Sgt. Mamerto D. Delgado was referred by the Hon. City Tyor to the Municipal Board for oppropriate action;

WHEREAS, the Committee on Police and Fire, Municipal Board, Ormo: City after Naving investigated the facts surrounding the death of the late Sgt. Mamerto D. Delgado four a out hat he lind in the line of duty;

WANNELS, the findings of the Committee on Police and Fire, Manual Aboard, Ormoc City was referred to the City torney, for his legal opinion and to determine whether the leirs of the late Sgt. Mamerto D. Delgado are entitled to celefits under Republic Act No. 784;

WHELMS, the City Attorney, Ormoc City, in his Legal Opinion No. III, dated November 12, 1954 ruled that the heir of the deceased, Mamerto D. Delgado, who died in the line of duty may be entitled to a death compensation or gratuity as provided for in Republic Act No. 784 by then receiving from the City and National Governments such compensation of ONE THOUSAND PESOS (P1,000.00) and funeral expenses in the amount of TWO HUNDRED PESOS (P200.00);

WHEREAS, Councilor Usualdo F. Laguitan suggested to the Hon. Members of the Board to appropriate the amount of \$\mathbb{P}600.00\$, representing the one-half (1/2) share of the City Government of Ormoc, to be paid to the heirs of the late Sgt. Mamerto D. Delgado by reverting said amount from the salary savings of the City Auditor to the General Fund;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to revert the amount of \$\mathbb{P}600.00\$ from the salary savings of the City Auditor to the General fund of the current fiscal year;

BE IT RESOLVED FURTHER, that the amount of \$\mathbb{P}600.00\$ as above reverted be paid to the heirs of the late Sgt. Mamerto D. Delgado as share (1/2) of the City Government of Ormoc of the total compensation of \$\mathbb{P}1,200.00\$ out of which one-half will be paid by the National Government
