## RESOLUTION NO.

WHEREAS, on manifestation of councilor suchoof. Laguitan to restore all city street lights that were eliminated beginning the current fiscal year due to several complaints of private citizens that the city streets are very dark during the night; and to respectfully request the aboitiz & Company to give the City Government of the constant of the constant of the constant of the next fiscal year's budget; 1455-62

WNERAMS, in connection with the restoration of city where lights mentioned above, Councilor Guillermo T. Parvilla sugrested to bring to the attention of the Aboitiz & Company the following points:

- 1. That the Ormoc Electric Company has no Electrical Engineer. By law they are required to have an Electrical Engineer;
- That the Ormoc Electric Light Company's generator is nor equipped with filter. A representation was made by this body in view of the many complaints of radio owners of the disturbances caused due to lack of filter;
- 3. The district of Naungan, Ormoc City, where the city street lights had been extended, lights there are just like a flicker and residents of said district have been complaining;
- 4. That the Ormoc Electric Light Company should give the right voltage. Even in the poblacion, the voltage is somewhat limited;
- 5. That the Ormoc Electric Company should make representation to the Aboitiz & Company to lower the rates;
- 6. That the Aboitiz & Company act on the request of the Municipal Board to have the boat every-day leave at night time;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to restore all city street lights that were eliminated beginning the current fiscal year and to respectfully request the Aboitiz & Company to give the City Government of Ormoc a chance to include the amount for payment of consumption of said additional lights this year during the next fiscal year's budget: year's budget;

BE IT RESOLVED FURTHER, to request the Aboitiz & Company to give favorable consideration on the points hereinabove brought out;

FINALLY RESOLVED, to furnish copy of this resolution each to the Hon. City Mayor; City Treasurer; City Auditor and the Manager, Ormoc Electric Company (Aboitiz & Co.) Ormoc City.
