Letter of Mr. Protasio P. Escoro, City Agronomist,
Ormoc City dated February 10, 1955, hereunder quoted

Sir:

Sometime during the middle of December, last year,
I wrote to the Municipal Board thru the City Treasurer
requesting for a transfer of funds in our department
under item Control of Pests and Diseases the current
budget in the amount of P100.00, to our traveling ex-
penses P70.00 and miscellaneous equipments P30.00.
These are very urgent in order to conduct our field
activities very efficiently. But until the present time
we have not heard from the Municipal Board any action
taken regarding our request.

It is therefore honorably requested that during
this coming regular session Saturday February 12, 1955,
this matter be treated thru your most emphatic desire to
improve our rural areas. Our National Government is giv-
ing us free insecticides and biologics so that the count-
erpart of our city is to furnish us our salary and travel-
ing expenses.

Diseases in the City Agronomist Office to the following:


P70.00 for traveling expenses
