RESOLUTION NO. 43

WHEREAS, be it known that Actg Vice Mayor Rafael M. Mejia of Ormoc City, had, in the interest of the welfare of the farmers of Ormoc City in particular and the residents of Ormoc City and neighboring towns in general, made representations to the President of the Philippines in order to secure enough amount to be spent for the irrigation project of Ormoc City;

WHEREAS, Actg Vice Mayor Rafael M. Mejia informed the Hon. Members of the Board that with the help of Speaker Protempore Daniel Romualdez of the 5th District of Leyte, he was able to secure the amount of ₱4,000,000 for said project and the same will be included in the next fiscal budget of the National Government;

WHEREAS, the Members of the Board, Ormoc City, unanimously agreed to express its profound gratitude to Actg Vice Mayor Rafael M. Mejia for his interest in calling the attention of the President of the Philippines about the irrigation project of Ormoc City which has not been realized up to the present;

NOW THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Porfirio Ayuyao and Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to officially express the profound gratitude of the Municipal Board of Ormoc City to Actg Vice Mayor Rafael M. Mejia for his interest in calling the attention of the President of the Philippines about the irrigation project of Ormoc City thereby securing an allotment for the City of Ormoc in the amount of ₱4,000,000 for said project;
