RESOLUTION NO. 40

Letter of Mr. Pelagio P. Codilla, in behalf of Mrs.
Filemona M. Codilla, dated March 16, 1955, hereunder
quoted verbatim as follows:

"March 16, 1955

"The Honorable
The Municipal Board
Ormoc City

Gentlemen:

This is to inform the Honorable Body that Mrs.
Filemona M. Codilla, a City Intermediate Teacher Ormoc
City was operated on in the Southern Islands Hospital last
Saturday, March 12, 1955 for removal of stone in the Gall
Bladder.

In view of the above circumstances, Mrs. Codilla's
hospitalization expenses has increased; and considering her
financial hardship at present, she requested the undersigned
to appeal to the Honorable Members of the Municipal Board
concerned to kindly consider the payment of her back salary
corresponding to the months of April, May and June 1954. It
is further informed that the estimate of her hospital ex-
penses, surgical operation and Ex-Ray Bill, would reach the
approximate amount of P500.00.

Regarding Resolution No. 32 of the Honorable
Body approved on February 26, 1955 which appropriated
P140.00 to pay Mrs. Filemona M. Codilla's one (out of two)
months back salary to be taken from salary savings of the
City Intermediate School of Ormoc City, the same amount is
not yet paid because the voucher was referred to the Division
Superintendent concerned for approval.

Therefore, should the Honorable Body be considerate
enough to extend her financial assistance, the amount that
should be appropriated would be the remaining two months
(May and June) back salary.

On the merits of the foregoing, the undersigned
most respectfully appeals to each and every members of the
Honorable Body to kindly consider the payment of the remain-
ing two months corresponding to May and June back salary for
and in behalf of Mrs. Filemona M. Codilla."

Jorge S. Tan;


BE IT RESOLVED, as is hereby resolved, to appropriate

CARRIED UNANIMOUSLY.


